Overview & Eligibility

Our Ultimate Powersport Theft Protection is a Limited Product Warranty, available to franchise and independent dealers. New and used Motorcycles, ATVs, UTVs, Scooters, Snowmobiles, Jet Boats, and Personal Watercraft are eligible without any age or mileage restrictions. This limited product warranty excludes commercial use.

Coverage

Warrantor ensures the Theft Protection Product, once installed, will deter potential thieves from stealing the Contract Holder's Powersport. In the event the Contract Holder's Powersport is stolen and deemed a Total Loss due to theft, the Warrantor will pay the benefit amount captured on the Limited Product Warranty or the NADA "clean trade in value" of the Contract Holder's Powersport at the time of loss, whichever is less.

In the event the Powersport is stolen and recovered, but not deemed a Total Loss, the Warrantor will reimburse the Contract Holder the cost to repair the Powersport, as determined by the Contract Holder's primary comprehensive insurance company, or the cost of the Contract Holder's comprehensive insurance deductible up to \$1,000, whichever is less.

The warranty may be assigned to any type of Theft Protection Product of the dealer's choice, including Alarm, Anti-Theft Dots, Etch, GPS, Radio Frequency and Tamper-Resistant Labels.

Terms and Benefits

The Limited Product Warranty begins on the Powersport sale date and expires 60 months thereafter or immediately after any benefit has been paid.

Additional Benefits

- **Powersport Replacement Rebate** – Warrantor will pay the Contract Holder an additional \$2,000 if a replacement powersport is purchased from the selling company prior to submitting a claim.

Street Legal Powersport Benefits*

- **Vehicle Rental** – Reimbursement up to \$35 a day, for a maximum of 15 days, not to exceed \$525.
- **Trip Interruption** – Lodging and meal reimbursement up to \$150 a day, maximum of 5 days, not to exceed \$750 if the Powersport is stolen when the Contract Holder is more than 100 miles away from their permanent residence.
- **Airfare** – Reimbursement up to \$500 for necessary airfare to return if the Powersport is stolen more than 500 miles away from the Contract Holder's permanent residence.

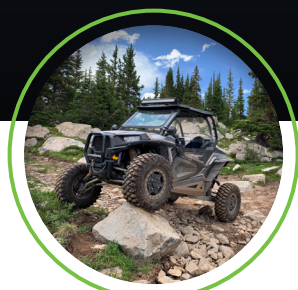

5 YEARS/\$5,000 BENEFIT

This **Limited Product Warranty** is assigned to the Theft Protection Product, **Powersport**, and **Purchaser** listed above. During the term of this **Limited Product Warranty**, the **Warrantor** ensures that the Theft Protection Product, once installed, will deter potential thieves from stealing **Your Powersport**. In the unlikely event **Your Powersport** is stolen and deemed a **Total Loss** as a result of theft, the **Warrantor** will pay **\$5,000** to **You** or the NADA "clean trade in value" of the **Powersport** at the time of loss, whichever is less.

INSURANCE DEDUCTIBLE REIMBURSEMENT

In the event **Your Powersport** is stolen and recovered, but not deemed a **Total Loss**, the **Warrantor** will reimburse **You** for either the cost of **Your** comprehensive insurance deductible up to **\$1,000** or the cost to repair **Your Powersport**, as determined by **Your** primary comprehensive automotive insurance company, whichever is less. The insurance deductible reimbursement benefit does not apply if **You** do not have comprehensive insurance on **Your Powersport** on the **Date of Loss**.

Once any benefit has been paid, this **Limited Product Warranty** and all benefits terminate. There is no deductible. This **Limited Product Warranty** begins on the **Powersport Sale Date** and expires **60** months thereafter.

IMPORTANT INFORMATION

THIS IS A **LIMITED PRODUCT WARRANTY** AND IS NOT INSURANCE. It is not subject to state insurance laws but is subject to state laws concerning warranties. Any change to the preprinted terms and conditions of this **Limited Product Warranty** is invalid and of no force or effect. If any information on this **Limited Product Warranty** is in error, contact the **Selling Company** or **Warrantor** immediately. **Purchase of the theft protection product is optional and is not required in order to purchase a powersport or obtain powersport financing.**

The duration of any implied warranties, including the implied warranties of merchantability and fitness for a particular purpose, is limited to the duration of this **Limited Product Warranty**. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to **You**. This **Limited Product Warranty** gives **You** specific legal rights, and **You** may have other rights which vary from state to state.

A. ADDITIONAL BENEFITS

The following benefits also apply, subject to the terms and conditions of this **Limited Product Warranty**:

1. **Powersport Replacement Rebate:** In the event **Your Powersport** is stolen and deemed a **Total Loss** as a result of theft, the **Warrantor** will pay **You** an additional **\$2,000** if **You** purchase a replacement Powersport from the **Selling Company** prior to submitting a claim to the **Warrantor**.
2. **Vehicle Rental Reimbursement:** In the event **Your Powersport** is stolen and deemed a **Total Loss** as a result of theft, the **Warrantor** will reimburse **You** for vehicle rental expenses up to \$35 a day, for a maximum of 15 days, not to exceed **\$525** during the term of this **Limited Product Warranty**. Rental reimbursement will apply only to the actual cost that **You** incur to rent a vehicle up to the purchase date of the replacement Powersport. This reimbursement does not include any amount covered by **Your** primary comprehensive automotive insurance policy. **This additional benefit is applicable only if Your Powersport is street legal. Legal requirements for powersport street operation may vary by state.**
3. **Trip Interruption Reimbursement:** In the event **Your Powersport** is stolen while **You** and the **Powersport** are more than 100 miles away from **Your** permanent residence, the **Warrantor** will reimburse **You** for lodging and meal expenses for up to \$150 a day, for a maximum of 5 days, not to exceed **\$750**. **This additional benefit is applicable only if Your Powersport is street legal. Legal requirements for powersport street operation may vary by state.**
4. **Airfare Reimbursement:** In the event **Your Powersport** is stolen while **You** and **Your Powersport** are more than 500 miles away from **Your** permanent residence, the **Warrantor** will reimburse **You** up to **\$500** for the necessary airfare to return **You** back to **Your** permanent residence. **This additional benefit is applicable only if Your Powersport is street legal. Legal requirements for powersport street operation may vary by state.**

B. LIMITS OF LIABILITY

This **Limited Product Warranty** applies only if the Theft Protection Product fails to protect **Your Powersport** from a theft during the term of this **Limited Product Warranty**. Our liability for incidental and consequential damages including, but not limited to personal injury, physical damage, property damage, loss of **Powersport** use, loss of time, inconvenience and commercial loss resulting from the operation, repair, maintenance or use of this **Powersport** is expressly excluded. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to **You**.

C. EXCLUSIONS

This **Limited Product Warranty** does not provide benefits:

- If **Your Powersport** was stolen by a member(s) of **Your** family or any other person(s) who had access to the keys of the **Powersport**.
- For any damage from collision or upset, falling missiles or objects, fire, explosion, lightning, earthquake, tornadoes, floods, malicious mischief, vandalism, civil commotion, riot, or acts of war.
- If **Your Powersport** is seized by a government agency.
- If **Your Powersport** is used for commercial purposes.
- For any claim resulting directly or indirectly from material misrepresentation; or any dishonest, fraudulent, or criminal act by any person(s) in lawful possession of the **Powersport**.
- For any theft occurring outside of the United States or Canada, or if the **Powersport** is registered outside the United States or Canada.
- If the **Powersport** has not been stolen.

D. PURCHASER RESPONSIBILITIES

You must comply with the following during the term of this **Limited Product Warranty**:

1. **In the event Your Powersport is stolen, You must notify the law enforcement agency having jurisdiction where the theft occurred within forty-eight (48) hours of theft.**
2. If part of the Theft Protection Product involves etching the windows, and if any window on **Your Powersport** is replaced for any reason, **You** must contact the **Warrantor** within thirty (30) days to arrange for etching of the replacement window. Failure to do so will result in denial of coverage under this **Limited Product Warranty**.

E. CLAIMS PROCEDURE

In the event of a claim, to receive any benefits listed on the first page of this **Limited Product Warranty**, **You** must provide the **Warrantor** with all the relevant documents listed below within thirty (30) days of the comprehensive automotive insurance settlement date. If **You** do not have comprehensive insurance coverage on the **Date of Loss** or **Your** comprehensive automotive insurance company denies **Your** claim, then **You** must provide the **Warrantor** with all the relevant documents listed below within sixty (60) days of the **Date of Loss**.

1. A copy of the police incident report
2. A copy of this **Limited Product Warranty**
3. A copy of **Your** comprehensive automotive insurance coverage information at the time of the theft, including proof of deductible paid, when applicable

4. A copy of the gross settlement figure from **Your** comprehensive automotive insurance company, when applicable
5. A copy of the settlement check from **Your** comprehensive automotive insurance company, when applicable
6. A copy of the **Selling Company's** invoice for the replacement powersport, when applicable
7. A copy of the receipts for rental car expenses, lodging, meals, and/or airfare, when applicable
8. In addition, if **You** do not have comprehensive insurance on **Your Powersport** on the **Date of Loss** or **Your** comprehensive automotive insurance company denies **Your** claim, **We** need the following:
 - a. A copy of the documentation from the police confirming that the **Powersport** hasn't been recovered at the time of claim, or
 - b. A copy of the appraisal confirming the damage from theft exceeds the NADA "clean trade in value" of **Your Powersport**, whichever applies.

Note: All submitted copies must be properly documented (and verifiable) before any claim can be processed for payment (handwritten copies will not be accepted). Failure to provide proper claim documentation within the assigned period will result in denial of coverage under this **Limited Product Warranty**. Material misrepresentation or fraud by **You** in the submission of a claim will result in denial of coverage under this **Limited Product Warranty**.

F. DEFINITIONS

- **DATE OF LOSS:** The date on which the theft of the **Powersport** occurred. If such date is indeterminable, the **Date of Loss** will be either the date established by the primary comprehensive automobile insurance company or the date the theft was reported to the police, whichever is earlier.
- **LIMITED PRODUCT WARRANTY, LIMITED WARRANTY:** This document in its entirety.
- **POWERSPORT:** The **Powersport** identified on the first page of this **Limited Product Warranty**.
- **PURCHASER, YOU, YOUR, MY, and I:** The person(s) whose name(s) is/are listed as the purchaser on the first page of this **Limited Product Warranty** or the person to whom this **Limited Product Warranty** was properly transferred.
- **SELLING COMPANY:** The entity identified on the first page of this **Limited Product Warranty** from whom **You** purchased **Your Powersport**.
- **TOTAL LOSS:** A **Total Loss** is defined as follows: (1) If **You** have comprehensive automobile insurance on the **Date of Loss**, the **Powersport** is a **Total Loss** when declared as such by the comprehensive automobile insurance company, or (2) If **You** do not have comprehensive automobile insurance on the **Date of Loss** or **Your** comprehensive automotive insurance company denies **Your** claim, the **Powersport** is declared a **Total Loss** if it's stolen and (a) not recovered within thirty (30) days of the **Date of Loss** or (b) recovered within thirty (30) days of the **Date of Loss** and an independent appraiser determines the cost to repair the damage from the theft exceeds the NADA "clean trade in value" of **Your Powersport**.

G. OTHER IMPORTANT INFORMATION

If a covered claim is not provided by the **Warrantor** or the **Warrantor** fails to meet any obligation under the term of this **Limited Warranty** within sixty (60) days after proof of loss has been filed, **You** may apply for reimbursement directly with the insurance company at the above address or by calling 1-800-282-8913.

H. CANCELLATION AND RENEWAL

This **Limited Product Warranty** has been provided at no charge to **You** with purchase of the Theft Protection Product and is non-cancellable by **You** or **Us**. This **Limited Warranty** may not be renewed.

I. TRANSFER

If the **Powersport** is sold, **You** may transfer this **Limited Product Warranty** within fifteen (15) days of the **Powersport** resale date. This **Limited Product Warranty** may not be assigned to another powersport, may not be transferred more than once, and may not be transferred to a new or used powersport dealer or anyone other than an individual person purchasing the **Powersport** directly from **You**.

To transfer the remaining coverage afforded under the terms and conditions of this **Limited Product Warranty**, contact the **Warrantor** for instructions at Transfers@iaawg.com. A transfer fee of twenty-five (\$25) dollars is required in the event of a transfer.
